- you have plans to apply for universities or other professional bodies which recognise and may ask for this English language test on their admission requirements.

#### The CIE IELTS Sponsorship Fund

- The CIE IELTS Sponsorship Fund shall be offered to full-time Associate Degree students in any Concentration Studies who have obtained a band score of 6.5 or above in IELTS test (Academic Module).
- Eligible recipients will obtain full sponsorship of the IELTS test fee.
- Each successful applicant is only eligible for the Fund once throughout his/her studies in the Associate Degree programme.

#### **Notes for Students**

1. Application should be submitted <u>from 18 April to 17 May 2024</u> through the <u>Online Application</u>. Students can enrol for a maximum of TWO enrichment courses in each semester.



- 2. Application will be processed on a first-come-first-served basis. Students will be notified of the enrolment results by email on 31 May 2024.
- 3. Successful applicants should pay the tuition fee for the enrichment course(s) on or before 14 June 2024. The Debit Note will be uploaded on MyBU-Study (<a href="https://cie.hkbu.edu.hk">https://cie.hkbu.edu.hk</a>) under the page "My Finance\Payment". Tuition fee paid is non-refundable and non-transferable.
- 4. The timetable will be released via MyBU-Study by the end of August 2024. No adding/dropping of course will be allowed but application for change of section shall be made via MyBU-Study during the add/drop period, if applicable.
