海運和航空業實習計劃 Maritime and Aviation Internship Scheme

****優化措施於2023年5月生效 Enhanced measure with effect from May 2023****

目的 提供有關海運及航空業實習職位，讓年輕一代及早了解行業所提供的多元化就業機會，鼓勵他們在畢業後投身兩個業界。

對象 本計劃的對象為可在香港合法受僱之香港居民，並同時是 —
1) 於本地院校修讀任何學士學位或副學位課程的本地全日制學生（包括準畢業生）；或
2) 於香港以外院校修讀任何學士學位或副學位課程的全日制學生（包括準畢業生）；或
3) 中六離校生*。

資助 提供實習職位的公司會向實習生支付每月酬金，當中「基金」會提供75%或7,000港元津貼（兩者以較低者為準），上限三個月。計劃全年接受申請。

Purpose

To offer young generation an opportunity to have an early exposure to the wide spectrum of career opportunities in the aviation and maritime sectors so as to encourage them to join the two sectors after graduation.

Target

- 1) full-time local students (including students who are in the final year of their study) undertaking undergraduate or sub-degree programmes in any local institutions; or
- 2) full-time students (including students who are in the final year of their study) undertaking undergraduate or sub-degree programmes in any institutions outside Hong Kong; or
- 3) secondary six school leavers *

Sponsorship

The MATF would reimburse the participating companies of the monthly honorarium paid to interns up to 75% or HK\$7,000 (whichever is the lower) for an internship period up to three months. Applications are received all-year round.

Maritime and Aviation Internship Scheme

Introduction

To offer young generation an opportunity to have an early exposure to the wide spectrum of career opportunities in the aviation and maritime sectors so as to encourage them to join the two sectors after graduation, the HKSAR Government established "Maritime and Aviation Internship Scheme" in 2014 to invite companies in the aviation and maritime sectors to offer intern places.

Eligibility

This initiative is open to the Hong Kong residents who are lawfully employable in Hong Kong and currently -

- 1) full-time local students (including students who are in the final year of their study) undertaking undergraduate or sub-degree programmes in any local institutions; or
- 2) full-time students (including students who are in the final year of their study) undertaking undergraduate or sub-degree programmes in any institutions outside Hong Kong; or
- 3) secondary six school leavers*.

Partnership arrangement

Government's support

- MATF would reimburse the participating companies of the monthly honorarium paid to interns up to 75% or HK\$7,000 (whichever is the lower) for an internship period up to three months.

Company's role

- register and offer internship places under MATF every year for a minimum of 4 weeks (i.e. 28 days);
- pay the monthly honorarium to the interns during the internship period, and then claim reimbursement from MATF regarding the sum sponsored by the Government, together with an evaluation of the Scheme, after completion of internship;
- give a fruitful and rewarding experience to the interns; and
- encourage and release the interns for activities organised by the MATF.

For students

Please refer to the information on intern places provided under the Internship Scheme as posted on the websites of the MATF and the above-mentioned education institutions. Participating students are required to submit the application for internship direct to the recruiting companies. Students will have opportunities to participate in exchanges / visits to be organised by the MATF. Upon completion of the internship, each student has to submit an evaluation form to the MATF via recruiting companies.
