2023 LANGUAGE PROFICIENCY ASSESSMENT FOR TEACHERS (LPAT) and 2023 HONG KONG DIPLOMA OF SECONDARY EDUCATION EXAMINATION (HKDSE) ORAL RECORDING SYSTEM (ORS) ASSISTANT

職責範圍

- 根據考評局的指引,在試場裝置及測試口試錄 影系統,並在每天口試完成後將器材收回及妥 善存放。
- 在口試進行期間向考務人員就操作口試錄影系 統提供技術支援。
- 3. 如系統失誤,向考評局即時報告,並根據指引 作出跟進,令系統運作恢復正常。
- 依從考評局每日提供的指引,妥善保存及運用 電腦器材。

申請人須:

- 具備中七或以上教育程度,並在香港中學會考獲 最少5科(包括中國語文及英國語文)E級/2 級或以上成績或
 - 具備中六或以上教育程度,並在香港中學文憑考 獲不少於五科 2 級/e 級/達標或以上的成績 (包括中國語文及英國語文);及
- 2. 熟悉操作電腦,一般應用軟件及運用視聽器材;及
- 3. 操流利廣東話及英語;及
- 4. 成熟及能獨立工作;及
- 5. 於提供服務前完成相關培訓及測試。

備註:

- 具備與上列同等/相若資歷的人士亦可被考慮。
- 具備考評局相關工作經驗的申請人可獲優先考慮考評局會以計分制度按申請者的監考工作經驗、 地區選擇及可執勤的日子作評選。

根據個人資料(私隱)條例,申請人須注意:

- 如未能提供全部所需資料,申請將不獲受理。
- 申請人所提供的資料只供作申請教師語文能力評核及香港中學文憑考試口試錄影系統助理之用。有關資料將予以保密。
- 未獲委派服之申請人的資料將在 2023 年 8 月 31 日後被銷毀。

Scope of Services

- Set up (including installation and testing) the Oral Recording System (ORS) at the assessment/examination centre according to the stipulated requirements before the start of the assessment/examination, and pack up the system after the assessment/examination.
- 2. Provide on-site technical support for the ORS during the assessment/examination.
- 3. Report ORS failure or incidents to the HKEAA for rectification.
- 4. Follow the daily operation checklist and maintain good inventory of the ORS.

Applicants should:

- have completed at least Secondary 7, and obtained in the Hong Kong Certificate of Education Examination Grade E / Level 2 or above in at least 5 subjects (including Chinese Language & English Language); or
 - have completed at least Secondary 6, and obtained in the Hong Kong Diploma of Secondary Education Examination Level 2 / Grade e / 'Attained' or above in at least 5 subjects (including Chinese Language & English Language); and
- 2. be familiar with Windows, software installation and operation of AV equipment; and
- 3. be able to speak Cantonese and English fluently; and
- 4. be mature and able to work independently; and
- have completed the required training and passed the compliance test before providing the service.

Remarks:

- Applicants with comparable/similar qualifications will also be considered.
- Preference will be given to applicants possessing relevant working experience with the HKEAA.
- Assignment will be made based on a point system with reference to applicant's invigilation experience, district preference and date availability.

- 實際的服務完成時間或因考試時間的進度而有所調整。
- □試錄影系統助理將以獨立服務合約形式被委派以提供服務。□試錄影系統助理的服務合約不構成任何香港 考試及評核局與□試錄影系統助理之間的僱傭關係。

Others:

- Applicants may be invited to a selection interview.
- Applicants selected to serve as Oral Recording System Assistants are required to attend a half-day training session in February and/or March 2023 and pass the compliance test conducted prior to the assignment of service.
- The actual finishing time may vary due to the progress of assessment.
- Oral Recording System Assistants are assigned to provide services as independent contractors. The service agreement does not give rise to any employment relationship between the Oral Recording System Assistants and the HKEAA.

Scope of Services:

- (a) Take attendance and check the identification documents of candidates;
- (b) Maintain discipline in the waiting room/preparation room;
- (c) Ensure compliance with the examination procedures and smooth conduct of the examinations; and
- (d) Attend to the instructions of the examiners.

Applicants selected to serve as Waiting Room Supervisors are required to attend a briefing session as below and pass a quiz, if applicable.

Normal sessions: in early March 2023

SEN sessions: in late March/Early April 2023

Requirements:

- (a) University graduate or under-graduate at Year 2 or above may also be considered;
- (b) Good oral and written communication skills in both English and Chinese (oral Cantonese);
- (c) Mature, patient, polite and pleasant personality;
- (d) Experience in dealing with students and teachers is an added advantage; and
- (e) Be punctual for work and be available throughout the whole examination period.

Assignment will be made based on a point system with reference to applicant's invigilation experience, district preference and date availability.

Closing Date for Application: 17 December 2022

Applicants should submit their applications online via the HKEAA's website (http://epo.hkeaa.edu.hk) between 21 November and 17 December 2022 (both dates inclusive). Applicants not notified by 21 March 2023 should consider their applications unsuccessful.
